10(a) Proposed Amendment to County Match Rule 15

From Surrey County Chess Association.

15. Before the time fixed for play, match captains shall exchange team lists indicating whether the rating list in force at the start of the season or the current month original rating list has been used for board order. If the rating list in force at the start of the season has been chosen, a player cannot be listed on a board below another who is rated (or deemed to be rated) more than 80 ECF rating points lower than the player.

The original published rating list for the current month shall be used, except for matches in the first week of the month when a captain may choose to use the preceding month's original rating list.

If the current monthly original rating list is chosen, players must be listed in rating order. If a captain's board order does not comply with this requirement, then the opposing captain may at his discretion insist, prior to the coin toss only, that the captain must provide an alternative board order complying with this rule.

If a list includes defaults, these must be on the lowest boards.

9(b) Proposed Amendment to County General Rule 5 (Eligibility of players)

From Kent County Chess Association:

The Kent proposal is to change 5 (c) (2) (ii) to 5 (d)

(ii) (d) If a player without a published start of season rating acquires an ECF rating (as category A or K) it will supersede the agreed estimated rating, effective one week after its publication (or earlier if the team captain so chooses). starts the season with a published ECF Rapidplay Rating, or a converted Active FIDE Rating, or is without a published start-of-season rating, these and any estimated Ratings will be superseded by their first published monthly ECF rating (category A or K). This It will supersede any clearance, or refusal of clearance, previously declared by the County Match Controller. Once acquired the rating will apply throughout the remainder of the season.

Rule 5 (d) becomes 5(e), and Rule 5(e) becomes 5(f).
